

Frank Lloyd Wright – Concrete Masonry Visionary

While FLW was not the concrete block's most ardent supporter, he had a vision of what was possible with concrete masonry: "What about the concrete block? It was the cheapest (and ugliest) thing in the building world. It lived mostly in the architectural gutter as an imitation of rock-faced stone. Why not see what could be done with that gutter rat? Steel rods cast inside the joints of the blocks themselves and the whole brought into some broad, practical scheme of general treatment, why would it not be fit for a new phase of our modern architecture? It might be permanent, noble beautiful."

Manufacturing Futures


