Membership Qualifications and Dues Formation

Producer Member Definition

Any firm, partnership or corporation headquartered in North America and Canada that manufactures masonry veneer products (see below) is eligible for Producer Membership in the Association upon terms to be fixed by the Board of Directors.

Dues Formulation (Producer Membership)

The producer member dues will be determined on a formula based on the reporting of the applicant's prior year sales in the masonry veneer industry to NCMA finance.

<u>Prior Year Reported Sales</u>	<u>Dues Ranges</u>
Less than \$5 million	\$5,000
\$5 - \$10 million	\$10,000
\$10 – \$25 million	\$ 20,000

Any firm, partnership or corporation engaged in supplying components, raw materials, equipment or services for the manufacture, distribution or installation of masonry veneer products or systems, may be admitted to Associate Membership in the Association.
